The Ouachita Council of Governments meeting was called to order by Mayor Jamie Mayo, Chairman. The meeting was held in the Council Chambers of the Monroe Government Plaza.

A public hearing was held at 11:30 a.m. to hear comments from the public regarding the TIP amendments. There were no comments from the public.

Mayor Jamie Mayo, Chairman, recognized Mayor Dave Norris, for his dedication and commitment, to OCOG. He mentioned Mayor Norris has worked many years on the OCOG board, and this will be his last meeting. Mayor Mayo, expressed his gratitude to working with the City of Monroe and the Parish, and wished him well. He also, stated Mr. James Bennett last meeting was May 29th, he also served on the OCOG oard for many years, his dedication and commitment is well appreciated.

Minutes

A motion was made by Mayor Dave Norris and seconded by Mr. Jack Clampit to approve the minutes of the May 29, 2018 meeting. Motion carried unanimously.

Long Term Recovery Executive Board

Mr. Kevin Crosby briefly reported on the Ouachita Strong Resiliency Strategy. He mentioned the Resiliency Strategy Public Meetings was held June 19th in Monroe and June 21st, in West Monroe, both meeting was successful. The next meeting of the Restore Louisiana Task Force is scheduled for Friday, July 13th at 9:30 a.m. in the House Committee Room 5 at the State Capitol. They are asking the representatives from Ouachita to strongly attend.

Neal Brown gave a Flood report update. He mentioned they are closer to meeting the targeted threshold that has been set, Ouachita target amount is around 2.5 million. To request a Presidential Disaster in Ouachita the damage amount is \$565,000, and the state threshold is 6.6 million. Before a Federal declaration can be requested, the state must have damages totaling 6.6 million, and the state is about \$150,000 to \$200,000 short of their total. FEMA has granted a 4-day extension to review the figures from Ouachita and atchitoches to check for over looked money between the two. Neal stated he will send out an email on Friday to give an update.

A motion was made by Mr. Scotty Robinson and seconded by Mayor Dave Norris to accept the Ouachita Strong Resiliency Strategy report. Motion carried unanimously.

OCOG drops AMR, selects Acadian as parish ambulance provider



In spite of protest from other ambulance companies, the Ouachita Council of Governments agreed earlier this week to make Acadian Ambulance the sole provider of ambulance services in Ouachita Parish.

OCOG's decision replaced American Medical Response, or AMR, who has served as the sole provider for years. OCOG is made up of elected officials from Monroe, West Monroe and the Ouachita Parish Police Jury. Each governmental entity is expected to take a vote ratifying OCOG's decision.

OCOG reached its decision based on the determination made by the Ouachita Parish Ambulance Advisory committee, which is made up of local hospital representatives, fire chiefs, and someone from the University of Louisiana-Monroe's College of Business.



"They've been working on this process for more than a year," said Assistant District Attorney Jay Mitchell, who serves as legal counsel for the Police Jury, OCOG, and the ambulance committee.

Of the three ambulance companies which offered proposals to provide ambulance services in the parish, Acadian, a Lafayette-based company, scored the highest with 934 points. AMR, of Colorado, scored 794 points. Pafford EMS, of Ruston, scored 702 points.

Acadian received not only the highest overall score but also the highest score on each individual committee member's scoresheets. The committee's recommendation to switch to Acadian was unanimous as was OCOG's decision on Monday to accept the recommendation.

Failed motion to close

time for remarks

Shortly after the meeting began, Police Jury President Scotty Robinson made a motion to amend the agenda and delete an item allowing each ambulance service provider to offer remarks. Robinson also is a member of the OCOG.

"The ambulance committee already has a recommendation for us," Robinson said. "I don't think this is necessary."

The vote to amend the agenda was 3-2, with Robinson, Police Jury Vice President Jack Clampit and Monroe Mayor Jamie Mayo voting in favor of denying time to offer remarks. West Monroe Mayor Staci Mitchell and West Monroe Board of Aldermen member Thom Hamilton voted against deleting the item.

After the 3-2 vote, Jay Mitchell — who also is Staci Mitchell's husband — asked to approach the council. After an off-the-record conversation with Jay Mitchell, Mayo said legal counsel had informed the council that state law required a unanimous vote to amend the agenda. In other words, the 3-2 vote was insufficient to remove the item from the agenda.

After the meeting, Hamilton and Staci Mitchell explained they had voted to keep the original agenda in place and allow ambulance companies to speak, because they were new to OCOG. Mitchell took office earlier this month.

"I felt maybe we should hear them out because we're new to OCOG," Hamilton said. "Because we were voting on a such an important thing, I wanted to make sure I heard everything."

Mitchell echoed Hamilton's remarks and noted the extensive review completed by the Ambulance Advisory Committee.

"It's hard to go against a committee when it has done all this work," Staci Mitchell said.

Robinson said he had sought to remove the item from the agenda, because he believed the two losing ambulance companies would use the time for remarks to sling accusations.

"I just wanted to avoid the negativity," Robinson said. "They've had a year, and they waited until today to complain."

AMR, Pafford object

OCOG did not take a vote on the matter until after considering some heated remarks from AMR as well as some objections from Pafford as well.

Before and after OCOG's meeting, AMR distributed materials to the press criticizing the Ambulance Advisory Committee's work.

In his remarks to OCOG, Chris Cirillo, AMR's regional director, claimed the Ambulance Advisory Committee did not consider certain questions after sending out its Request for Proposals, or RFP.

"This RFP is very concerning," Cirillo said. "We believe the RFP process was flawed."

Later, Cirillo explained the RFP process did not provide certain information to ambulance companies seeking the parish's business.

"No bidders were provided detailed response data," Cirillo said.

Cirillo pointed out AMR had served as the parish's ambulance service provider for some 40 years.

If OCOG selected Acadian, the council would be choosing "slower response times" and "higher bills for citizens," according to Cirillo.

"If you select Acadian, there is no doubt citizens will have slower response times and higher costs," Cirillo said.

Cirillo claimed AMR had proposed a fleet of 25 ambulances while Acadian's proposal entailed only 19.

Mike Seymour, chief medical officer with Pafford EMS, claimed Pafford had faster response times than Acadian and referred to other qualifications in the RFP process as "fluff RFP."



No public subsidy?

When Cirillo claimed that AMR did not ask for a public subsidy, both Robinson and Jay Mitchell corrected him.

"AMR has not asked for a public subsidy," Cirillo said.

Robinson pointed out that AMR's proposal entailed a "free version" for ambulance services, but AMR also had requested up to \$1.5 million in a public subsidy each year to provide toplevel service.

Acadian would provide ambulance services in Ouachita Parish at no cost to parish taxpayers.

Jay Mitchell, who has frequently commented on the historically factious nature of RFPs for the parish's ambulance service provider, said AMR's different versions, whether paid for with \$1.5 million in public funds or its "free version," were not directly comparable to the proposal offered by Acadian.

"Let me say this," Jay Mitchell began. "I've said this before, but I equally dislike all of these ambulance companies, because of this. I'm not here for any other reason than to report on behalf of the committee. If something is stated incorrectly, I want to say something."
